## New Business:

Sam and Wendy are looking for a second school where bridge can be taught, and they are looking for other teachers as well.
- 6. **Bylaws Revision Update.** Stuart reported that all is ready for the vote on a new set of bylaws to be held February 16. The notice has been posted at the clubs and on the Unit website, in compliance with current bylaws.
- 7. **Swiss Boards Refresh.** The duplicate boards used at our sectionals for Swiss teams games need to be refurbished. Pete will set up a "work party" to accomplish this task. Jane, Sam, and Stuart agreed to help.
- 8. **e-Blasts.** The cost of the Pianola software to send e-Blasts turns out to be less than we anticipated. Subject to confirmation of the cost, it was unanimously agreed to contract with that service. Pete and Kathy will follow up.
